This form (or an equivalent form with the same information) shall be used by the producer of the adhesive (or of the adhesive components in case of two- or multi-component adhesive systems) to certify compliance with requirements according to IKEA specification IOS-MAT-0069 version AA-279868-5, as well as adhesive formaldehyde level according to IOS-MAT-0003 version AA-10899-15, when applicable, and shall comply with the general verification rules for self declarations stated in IOS-PRG-0089.

Supporting documents, verifying the fulfilment of the requirements, can be listed in *Table 6*, such as:

- Test reports (TR)
- Self declarations (SD) or certificates from raw material and chemicals used to make the adhesive suppliers
- Safety Data Sheets (SDS)
- Technical Data Sheets (TDS)
- Approval Documents (shall be listed if applicable)

When a material or additive is purchased from several sub-suppliers, include references to supporting documents from each sub-supplier.

Even if this form is signed by a sub-supplier (or sub-sub-supplier) to the IKEA supplier, the IKEA supplier always has the final responsibility towards IKEA for compliance with IKEA requirements.
